

Ozarka® Brand Texas State of Cool
Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Ozarka® Brand Texas State of Cool (the "Promotion") is open only to legal residents of Texas who are at least eighteen (18) years old at the time of entry. Employees of BlueTriton Brands, Inc. ("Sponsor"), Merkle Inc. ("Administrator"), and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee, whether or not related, are not eligible. Administrator's computer is the official time-keeping device for this Promotion.
